- 5. Electronic bids must be submitted to the office Dewangunj Rural Municipality, Dewangunj, Sunsari, Province -1, Nepal through PPMO website www.bolpatra.gov.np/egp/.on or before 12:00 Noon on 31<sup>th</sup> day of publication of notice. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders representatives who choose to attend at 2:00 pm on 31<sup>st</sup> day of publication of notice at the Dewanganj Rural Municipality Office, Dewanganj, Sunsari, Province 1, Nepal.
