Dewangunj Rural Municipality office invites electronic bids from eligible bidders for the Single year project of **Two Room Buliding Construction Works at Islamiya School Dewangunj-02, Construction of Agriculture Market at Wada No-3 & Upgrading Road with Black Top(Asphalt works),Dewanganj-07(Dewanganj Ga.Pa Wada No.-07 dekhi purba Hakpara way Roads)** under National Competitive Bidding – Single Stage Single/Two Envelope Bidding procedures.

1. Under the Single Stage Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope & Single Stage Single Envelope Bidders are required to submit the Price Bid only in turn enclosed in sealed envelope Procedure for as per the provision of ITB 21 of the Bidding Document.

5. Electronic bids must be submitted to the office **[Dewangunj Rural Municipality Office, Dewangunj, Sunsari, Koshi Province]** through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **[10:15 AM]** on **[2082/07/30]**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **[2:00 PM on 2082/07/30]** at the office of **[Dewangunj Rural Municipality Office, Dewangunj, Sunsari, Koshi Province]**. Bids must be valid for a period of **[90days]** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **As per PPA & PPR**, which shall be valid for 30 days beyond the validity period of
